In June The Pamlico County Sheriff's Office responded to a record number of drug overdoses in Pamlico County. During the investigation of the overdoses, the sheriff's office identified numerous individuals involved in the distribution of heroin and other deadly drugs in the County. In the month of July, Deputies with the Sheriff's Office responded to a number of citizen complaints about suspected drug activity, conducted undercover controlled purchases of narcotics, executed search warrants and performed proactive patrols in areas where complaints were received. The two-year associate's degree program, which recently received state approval, will train students to create dental appliances such as dentures, partials, bridges, crowns and other prostheses.  
Program graduates will be qualified to work in denture clinics, dental labs and similar settings.  
PCC's program will be led by Kathy Nicodemus, who has more than 30 years of combined experience teaching Dental Technology and working in the dental prostheses industry.  
"We are very excited to offer a new career option for students," said PCC President Dr. Jim Ross. "We believe this program will create wonderful opportunities for students to have great careers and improve their lives."  
The new Dental Laboratory Technology program will be unique in the area. In fact, PCC

will be the only N.C. community college east of Interstate 95 to offer the degree program.  
The program will consist of classroom teaching and hands-on work in the lab. There also will be online instruction.

Financial Focus      Diversify Your Investments ... But Consolidate Your Providers

You have probably heard that diversification is a key to investment success. So, you might think that if diversifying your investments is a good idea, it might also be wise to diversify your investment providers – after all, aren’t two (or more) heads better than one?

Before we look at that issue, let’s consider the first half of the “diversification” question – namely, how does diversifying your investment portfolio help you?

Consider the two broadest categories of investments: stocks and bonds. Stock prices will move up and down in response to many different factors, including good or bad corporate earnings, corporate management issues, political developments and even natural disasters. Bond prices are not immune to these dynamics, but they are usually more strongly driven by changes in interest rates. To illustrate: If your existing bond pays 2 percent interest, and new bonds are being issued at 3 percent, the value of your bond will fall, because no one will pay you full price for it. (Of course, it may not matter to you anyway, especially if you planned to hold your bond until maturity, at which point you can expect to get your full investment back, providing the bond issuer doesn’t default.)

Here’s the key point: Stocks and bonds often move in different directions. If you only own U.S. stocks, you could take a big hit during a market downturn, but if you own domestic and international stocks, bonds, government securities, certificates of deposit and other types of investments, your portfolio may be better protected against market volatility, and you’ll have more opportunities for positive results. (Keep in

mind, though, that even a diversified portfolio can’t prevent all losses or guarantee profits.)

So, it clearly is a good idea to diversify your investment portfolio. Now, let’s move on to diversifying financial service providers. Why shouldn’t you have one IRA here and another one there, or enlist one advisor to help you with some types of investments and a different advisor assisting you with others?

Actually, some good reasons exist to consider consolidating all your investment accounts with one provider. For one thing, you’ll keep better track of your assets. Many people do misplace or forget about some of their savings and investments, but this will be far less likely to happen to you if you hold all your accounts in one place.

Also, if you have accounts with several different financial service providers, you might be incurring a lot of paperwork – and many fees. You can cut down on clutter and expense by consolidating your accounts.

State Education Board Approves \$2.5 Million In Budget Cuts To DPI

RALEIGH — The State Board of Education has approved \$2.5 million in budget cuts to the Department of Public Instruction. The savings will come from staff cuts and operating expenses.

An additional \$737,285 will be cut in a few weeks to meet the \$3.2 million cut required by the 2017-19 state budget plan.

The decision to make the cuts was unanimous. Of the \$2.5 million cut approved by the State Board, \$1.6 million are staff cuts, and \$865,168 are reductions in operating expenses.

The staff cuts include seven full-time positions, eight vacant positions, and three temporary positions. Additionally, the months worked for 19 instructional coaches will fall to 10 months from 12. They also will undergo pay cuts.

Of the vacant positions, six will be cut from the District and School Transformation Division, one from the Educator Effectiveness Division, and one from the Curriculum and Instruction Division.

The board didn’t specify the other positions facing reduction, but it plans to announce them at some point. State Board Chairman Bill Cobey intimated some of the position cuts would result from a merger of the District Transformation Division and the Educator Effectiveness Division into the District Support Division.

Terry Stoops isn’t surprised the District Transformation Division and the Educator Effectiveness Division will face the most cuts.

Consultants mostly comprise their staffs.

“The fact that only 10 filled positions (seven full-time and three temporary jobs) will be eliminated suggests that members of the State Board of Education tried to minimize the loss of employment,” wrote Stoops, director of research and education studies at the John Locke Foundation.

Cobey made clear the board aimed to cut redundant positions to mitigate the impact on students.

“We certainly will work with our human resource division and others involved in this process to see that this reduction is implemented with as much compassion and concern as possible,” he said.

Eric Davis, a member of the State Board of Education, is worried the cuts may affect students.

“These reductions will adversely impact our students, especially those in districts and schools that rely most heavily on the Department of Public Instruction,” Davis said. “It is my hope that in future years our superintendent in partnership with the General Assembly will prevent future adverse impacts to our students.”

Stoops countered Davis’ prediction, arguing the size of the department doesn’t necessarily determine outcomes.

“The idea that student performance will suddenly drop because of these cuts is kind of a silly idea,” Stoops argued. “It is the quality of teachers that makes a difference.”

Lawmakers Open Redistricting Process

RALEIGH — A joint legislative redistricting committee met Wednesday to begin the court-ordered process for redrawing a minimum of 28 legislative electoral maps.

Sen. David Lewis, R-Harnett, chairman of the House redistricting committee, said the goal is to get input from public hearings in August, September, and October. That would be added to lawmakers’ recommendations to create criteria to use and have new maps prepared for a redistricting special session in November.

Although state and county populations have been in flux the past seven years, Lewis said the General Assembly must use 2010 Census data in drawing new maps. An ideal Senate district is made up of 190,710 people; an ideal House district is made up of 79,462 people.

Rep. Mickey Michaux, D-Durham, issued warmed-over talking points as Democrats peppered Lewis with questions. He said the current General Assembly was “operating with an unconstitutional make-up” because a three-judge federal court panel declared nine Senate and 19 House districts drawn in 2011 were unconstitutional gerrymanders.

The panel said Republicans relied too heavily on race in drawing the maps but found no ill intent or discriminatory motivation.

After the meeting, Sen. Ralph Hise, R-Mitchell, chairman of the Senate redistricting panel, dismissed any notion the General Assembly

was acting improperly by meeting despite the judges’ ruling.

“I would say that under any circumstance, and under historical and even federal court rulings, that once we are sworn in as a body we have full authority to act as that body,” Hise said.

Hise, like other lawmakers, had no insight on what action might be taken at Thursday’s hearing in Greensboro on the so-called Covington case by the three-judge panel in U.S. District Court for the state’s middle district.

“I think the [U.S.] Supreme Court was clear in telling the court that they had to consider the impact on the states, and that previously they had not done so,” Hise said. Given that admonition he expects the three-judge panel to give greater deference to the state constitution, and the impact any decision would have on the state.

Hise said he does not expect the court to take an extreme route forcing the state to ignore vital parts of its constitution, but warned GOP lawmakers would be prepared to fight if it did.

Among the many complicating factors of this case is that it would be impossible to draw new maps for just the 28 districts declared unconstitutional gerrymanders. Lawyers for Republican leadership said in court filings up to 81 of 120 House seats, and 35 of 50 Senate seats would be affected.

Jones Supports Expanded GI Benefits For Veterans

WASHINGTON, DC – This week, Congressman Walter B. Jones (NC-3) continued his strong support for veterans and military families of Eastern North Carolina by voting for legislation to greatly expand GI bill benefits. The GI bill was first created after World War II to help veterans with educational programs, vocational training, and housing assistance following their service. Enactment of this week’s legislation – H.R. 3218, the Harry W. Colmery Veterans Educational Assistance Act – would be the biggest GI bill expansion in a decade. H.R. 3218 would allow veterans to use their education benefits throughout their lifetime, not just during the 15 years following their service, as is currently the case. H.R. 3218 would also give full GI bill eligibility to all post-9/11 Purple Heart recipients, regardless of how long they served. Currently, post-9/11 Purple Heart recipients need to put in three

years of service to receive full benefits.

“It is an honor to be part of an effort to improve the benefit package for those who put their lives on the line for us,” said Congressman Jones. “They certainly deserve it.”

Now that H.R. 3218 has passed the House of Representatives, the bill will head to the Senate for further consideration.

Serving America’s veterans is one of Congressman Jones’ highest priorities. Over the past 12 years, Congressman Jones has cosponsored more bills to help veterans than any other member of Congress.

Silverbrook Cemetery Needs Your Support

Burial spaces have been an integral part of any community and Oriental is no exception. Most are familiar with the main cemeteries in Oriental. (If not, they are described in the book “Cemeteries of Pamlico County” housed in the Oriental History Museum). One cemetery in particular, Silverbrook, in Oriental, has a rich history. The Silverbrook cemetery as it is now called has evolved from a tiny plot known as Tranquil Cemetery to the right of Silverbrook Road to the newer portion formerly known as Blackwell Cemetery which is to the left of Silverbrook Road. The oldest tombstone recorded at Silverbrook is for that of 2 year old Ada Irene who died in 1896.

Another notable gravesite is Betty Patton’s. Her head stone is a goose (once displayed in her yard) that wears pinafores, wigs, a graduation gown, hats, and even a wedding dress. She is named Gertie and Gertie changes outfits every few weeks, depending on the season or events in the calendar. She’s been a butterfly, worn a rain slicker, and a lot of dresses. And just about always, a smartly styled hat makes the outfit complete. See the entire story on Townsend.net where Gerti was chosen as the July, 2016 Pet of the Month.

The care of the cemetery is the longest ongoing community service project of the Oriental Woman’s Club. It began in October 1922 and was funded by public donation. In 1935 a plan was devised whereby cemetery lot owners paid the Club for the upkeep of their lots by an annual fee or, beginning in 1980, a one-time perpetual care payment.

This plan proved very successful for some time. With interest rates at an all-time low, the perpetual care fund is not generating enough to pay for maintenance of the cemetery. The problem is compounded by an increasing number of families who had paid an annual fee, but for whom no current address is available.

When it was created many years ago, the Oriental Cemetery served the needs of a community whose population lived secure in the belief that succeeding generations would live here and care for the graves. In recent times, life and careers have taken younger members of some of the families miles from their Eastern Carolina home, and they rely on the Oriental Woman’s Club to care for the cemetery they left behind. The Club values the expressions of affection and the thanks it receives from grateful relatives for the loving care it takes of family plots and family history.

We would like to continue to provide this service to the community but as funds diminish it becomes increasingly difficult to manage this project. Therefore, we come to the public and would greatly appreciate any help you can provide. The Oriental Woman’s Club is a 501 (c)(3) non-profit organization and contributions are tax-deductible. 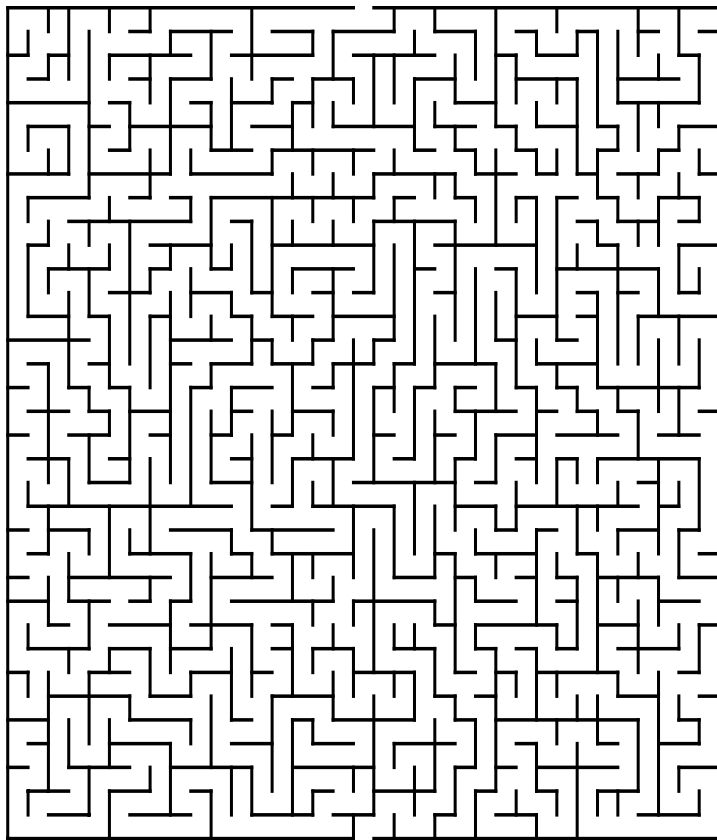

## NC Coastal Federation Awarded Grant To Conduct Cleanup



**HARKERS ISLAND** — The North Carolina Coastal Federation has been awarded a grant from the National Oceanic and Atmospheric Administration (NOAA) to clean up marine debris near Harkers Island.

This large-scale cleanup is set to begin this fall.

The project will remove tons of debris left behind from a clam-growing operation that went out of business decades ago. Plastic, netting, cages, buoys, pipes and ropes are creating navigation hazards, and are littering salt marshes, seagrass beds and oyster beds.

Over the years, storms have caused this trash to end up on shorelines and in salt marshes.

"It will be good to remove this junk, and restore these waters to their once pristine condition," said Todd Miller, executive director of the federation. "More importantly, we will use this project to help ensure that existing and future shellfish farming operations don't contribute to marine debris problems going forward."

The grant will allow the federation to work with shellfish growers and other interested stakeholders to devise best management practices for disposal and prevention of marine debris that could be generated by shellfish mariculture operations. The project will also utilize drone technology to identify debris impacts on habitat and monitor habitat recovery.

"Most growers do a good job of policing themselves by removing gear and cleaning up their operation, especially after storms," said Bree Tillett, coastal specialist for the federation. "We will look to develop some additional safeguards to ensure that a few bad actors

don't give the entire shellfish mariculture industry a bad name."

A jointly developed presentation on best management practices related to marine debris will be delivered by North Carolina Sea Grant to all aquaculture lease applicants in order to prevent this from happening in the future. These best management practices will be incorporated into Sea Grant's classes for shellfish growers and lease holders.

The federation will hire a marine contractor to assist with this cleanup. The federation will also host five shoreline cleanups in order to spread the message about this project. All materials cleaned up at the site will be cataloged and weighed.

This project is being conducted in close partnership with Duke University Marine Laboratory and the NOAA Beaufort Laboratory.

**MOREHEAD CITY** — The N.C. Division of Marine Fisheries has certified a new state record for gag grouper.

Breece Gahl reeled in the 47-pound, 6-ounce fish May 20 while fishing in the Atlantic Ocean 30 miles off Wrightsville Beach.

The fish measured 48 inches total length (from the tip of the nose to the tip of the tail) and had a girth of 26 inches.



The former state record for gag grouper was 46 pounds. It was caught off the coast of Ocean Isle in 2011. The world record for gag grouper is 80 pounds, 6 ounces. That fish was caught off the coast of Destin, Fla. in 1993.

Gahl caught his fish using cigar minnows for bait on 120-pound braided line test.

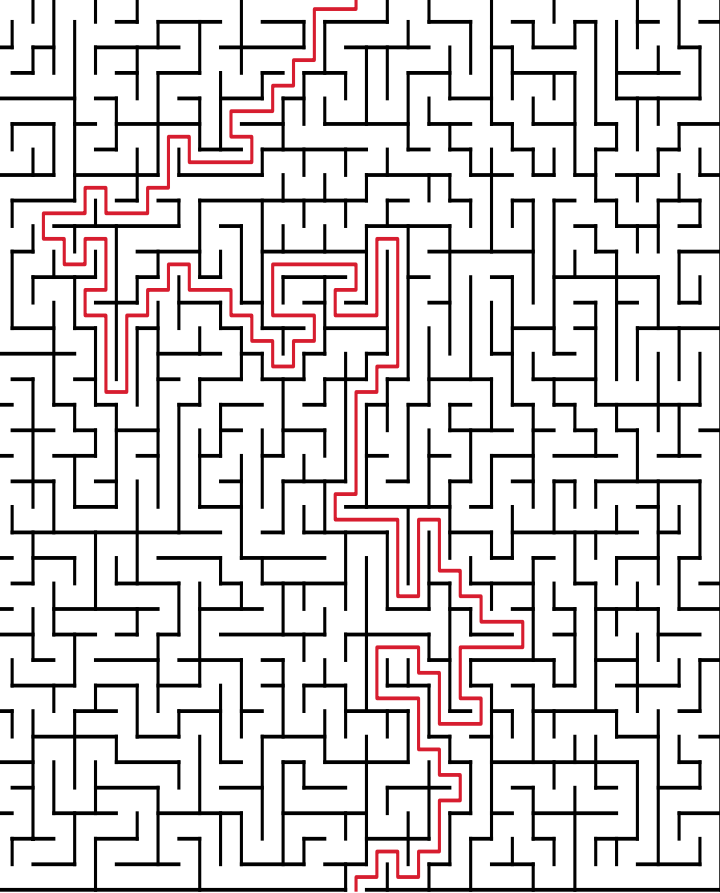

## Broiled Crab Sandwiches

1-1/2 pounds fresh crabmeat  
1 package (8-oz.) cream cheese  
1/2 cup grated Cheddar or Gouda cheese  
1 teaspoon prepared horseradish  
1/4 teaspoon Tabasco sauce  
1 teaspoon prepared mustard  
1/4 teaspoon garlic salt  
Mayonnaise  
Combine the above ingredients, adding desired amount of mayonnaise to moisten. Spread mixture on buttered English muffin halves or 1-inch slices of Italian bread. Place on baking sheet under broiler and toast until bubbly and brown.

## Blue Crab Casserole

1 pound fresh crabmeat  
2 slices bacon  
1/2 cup finely chopped onions  
1/2 cup finely chopped celery  
1/4 cup finely chopped bell pepper  
1 clove garlic, minced  
2 cups crushed saltine cracker crumbs  
1 teaspoon dry mustard  
1/2 teaspoon salt  
2 teaspoons chopped parsley  
Dash cayenne pepper  
1 egg, beaten  
1/4 cup milk  
1 stick melted butter or margarine  
1 teaspoon Worcestershire sauce  
Remove shell and cartilage from crabmeat. Cook the bacon until crisp. Crumble and set aside. Sauté the vegetables in the bacon drippings. In a large mixing bowl, combine the cracker crumbs and dry ingredients. Add all other ingredients and mix thoroughly. Place mixture in a generously buttered baking dish and bake in 350 degree oven for 30 minutes. Serves 6 to 8.

## Trout Almandine

2 pounds trout fillets (or other fillets)  
1/4 cup all-purpose flour  
1 teaspoon salt  
1 teaspoon paprika  
1/4 cup butter or margarine, melted  
1/2 cup sliced almonds  
2 teaspoons lemon juice  
4 or 5 drops Tabasco sauce  
1 tablespoon chopped parsley  
Cut the fillets into 6 serving portions.

Combine the flour, salt and paprika. Roll portions in the flour mixture and place in a single layer-skin side down-in a well-buttered baking dish. Drizzle 2 tablespoons of the melted butter over the portions. Broil about 4 inches from source of heat for 10 to 15 minutes or until fish flakes easily when tested with a fork. While fish is broiling, sauté the almonds in remaining butter until golden brown, stirring constantly. Remove from heat and mix in lemon juice, Tabasco and parsley. Pour over fish. Serve immediately. Serves 6.

## Crispy Fried Catfish Fillets With Relish

6 skinned, pan-dressed catfish fillets (or other firm fish fillets)  
1/2 cup evaporated milk  
1 tablespoon salt  
1/8 teaspoon pepper  
1 cup all-purpose flour  
1/2 cup yellow or white cornmeal  
2 teaspoons paprika  
Vegetable for frying  
Lemon Relish (recipe follows)  
Wash and pat fillets dry. Combine the milk, salt and pepper. Combine the flour, cornmeal and paprika. Dip fish in milk mixture and then roll generously in flour mixture. Fry fish in hot oil for about 4 minutes. Turn carefully and fry for 5 or 6 minutes more or until fish is brown and flakes easily when tested with a fork. Drain on paper towels and serve immediately with Lemon Relish. Serves 6.

## Lemon Relish:

1/2 cup sour cream  
1/4 cup crushed pineapple, drained  
2 tablespoons diced peeled lemon pulp  
2 tablespoons finely chopped green pepper  
1 tablespoon finely chopped onion  
1 tablespoon light brown sugar, packed  
1 teaspoon grated lemon peel  
1/4 teaspoon dry mustard  
1/4 teaspoon celery salt  
1/8 teaspoon ground cloves  
Combine all ingredients and blend well. Cover and chill. Makes about 1 cup relish.

## Supreme Broiled Trout

2 pounds trout fillets, skin removed (or other fresh fish fillets)  
2 tablespoons grated onion  
1-1/2 teaspoons salt  
1/8 teaspoon pepper  
2 large tomatoes, cut into small pieces  
1/4 cup butter, melted  
1 cup Swiss cheese, shredded  
Place the fillets in a single layer on a well greased bake-and-serve platter or baking dish. Sprinkle with onions, salt and pepper and cover with tomato pieces. Pour butter evenly over the fillets and broil about 4 inches from source of heat for about 10 minutes or until fish flakes when tested with a fork. Sprinkle fish with shredded cheese and broil about 3 minutes longer or until cheese melts. Serves 6.

Combine the shredded cabbage, green peppers and chopped onions and toss to blend. Place mixture in a large bowl. Sprinkle 1 cup of the sugar and the salt over the cabbage mixture. Heat the vinegar, celery seeds, oil and the 2 remaining teaspoons sugar. Cool the mixture and then pour over the cabbage mixture. Toss to thoroughly combine. Store in covered contained and place in the refrigerator. Slaw will keep very well for about one week.

## Cucumber Sauce

*This is a great sauce to serve over crisp lettuce or with fried or baked seafood.*

1 cup whipping cream  
1/2 teaspoon salt  
1/8 teaspoon cayenne pepper  
1/4 teaspoon onion juice  
2 tablespoons vinegar or lemon juice  
1 cucumber, finely chopped  
Beat the cream until thick. Add the salt and cayenne pepper. Gradually add the vinegar or lemon juice and beat well. Fold in the cucumbers and onion juice, cover, and place in the refrigerator to chill. Serves 6.
