Sailors Compete In Biggest Regatta In NC

By Joy Mccracken 16 colleges and 20 teams from New Jersey to Florida participated in the fourth annual 2018 SailPack Oriental Intercollegiate Regatta this past weekend which was sponsored by River Dunes, Alamance Foods and Deaton Yacht Sales. This was the largest ever college regatta held in NC. Teams included NC State (the host), UNC, Clemson, William & Mary, VA Tech and USC. Teams launched from the Bow-to-Stern Boating Center (which also supplied the boats) and racing took place within view of Lou Mac Park. "The SailPack Oriental Intercollegiate Regatta has become a truly special event in the college sailing calendar," said NC State Sailing head coach Dana Magliola. "Aside from

great sailing and fierce competition

in Oriental and Pamlico County is

legendary and the legacy of sailing in this community is unmatched in North Carolina."

Two teams from Jacksonville University participated finishing first and second overall. Clemson finished third and Host, NC State with two teams competing finished eleventh and fifteenth.

This regatta has become so popular that there is now a waiting list for other colleges to join.

The teams were from two different conferences, the Mid Atlantic Intercollegiate Sailing Association and the South Atlantic Intercollegiate Sailing Association. Each team had two boats undertaking double-handed dinghy sailing that were sloop rigged on the FJ (Flying Junior) models.

Military Training Operations



MARINE CORPS AIR STATION CHERRY POINT - U.S. Army helicopters will operate in and around Marine Corps Outlying Landing Field Atlantic April 16-27 as late as midnight each night.

Kershner Assumes Leadership Role Of Pamlico's EDT Program

Bonnie Kershner knows her way around the human brain.

The 40-year-old Michigan native is a registered polysomnographic technologist (RPSGT) and has nearly two decades of experience conducting sleep studies.

Her past workplaces have included hospitals, clinics and private practices, and she has helped hundreds of patients learn how their brains and bodies are working while they are asleep.

Now Kershner is taking on a new role: She is the new Program Director for Pamlico Community College's Electroneurodiagnostic Technology (EDT)

In her new job, Kershner will handle the administrative and accreditation demands of the EDT program while Instructor Leslie Jones will focus on teaching and working with students, many of whom take the program online.

"I'm excited to see the EDT program grow," Kershner said recently.

The college's EDT program trains students to conduct sophisticated tests on the electrical waves in a patient's brain and spine. Those tests often are critical in the diagnosis and treatment of seizures, strokes and other neurological problems, including dementia and ALS.

PCC's EDT program, which is accredited by the Commission on Accreditation of Allied Health Education Programs (CAAHEP), is one of two now operating at community colleges in North Carolina. It can be completed

entirely online.

Kershner said many of the skills required in EDT are very similar to her work overseeing sleep studies. She also says she is no stranger to the rigors of maintaining accreditation and meeting goals.

"It's not foreign to me," Kershner said with a smile as she held up a thick manual of accreditation require-

PCC President Dr. Jim Ross said he was happy to have Kershner on campus.

"EDT is one of PCC's premier programs, and it is one that produces well-trained professionals who will make lives better throughout their careers," he said. "I am glad Bonnie Kershner has joined our EDT program. I look forward to the contributions she will make to its continued excellence."

Kershner grew up near Detroit and earned her bachelor's degree in psychology from the University of Michigan in 1999.

She and her husband moved to Eastern North

Carolina in 2004 to be closer to members of his family. The Kershners live in New Bern and have two daughters, ages 8 and 10. Kershner has spent her first days on the job becoming familiar with the

program and getting to know her new colleagues. "Everyone has been very helpful," she said. "I'm learning every day." For more information about the college's EDT program, please call 252-

New Bern Battlefield Park Joins Civil War **Trust In Park Day**

Since 1996, the Civil War Trust has sponsored Park Day, an annual hands-on preservation event to help Civil War, Revolutionary War, and War of 1812 battlefields and historic sites take on maintenance projects large and small. This year on April

Bern's Battlefield Park will join in this national event. While our beautiful park reflects the work of many volunteers from Battlefield Guides clearing trails,

to Boy Scouts building observation platforms to Marines building bridges, there is always much to be done. Jon Miller, Battlefield Manager hopes volunteers will help clear out the original Civil War fighting positions and do some general Spring cleaning "Whil we expect this to

be a work day, we also expect it to be a fun day." The first 45 volunteers will receive a T-shirt commemorating the day. Hot dogs and drinks will be provided by Event Sponsor Gibbs Dentistry. New Bern Historical Society's Executive Director, Mickey Miller adds "We are thrilled to be joining the Civil War Trust's national effort to preserve battlefields as a part of our historic fabric. But you don't have to stay and work, just come to learn more about this historic treasure."

Volunteers are asked to arrive at the park at 10am. We will begin with a short tour of the battlefield before working. Bring work gloves and a rake if you like, a limited number of gloves

will be available. Wear sturdy shoes and clothing appropriate for weather forecast. New Bern Battlefield Park is located at the entrance to the Taberna subdivision off Highway 70 at 300 Battlefield Trail New Bern, NC 28560.

Everyone is welcome. Individuals or groups can volunteer. Scout groups, church groups, school groups and clubs have all helped out at the park in the past. The Historical Society owns and main-

tains the park, and encourages everyone to come out and enjoy the day. The park recently expanded the history walk with a \$250,000 upgrade to trails and interpretive signage. The gateway plaza was added featuring a 20 foot in-ground concrete map displaying the battle area and noting the loca tions and actions

of all the units that took part in the Battle of New Bern. All of this was done by private funds. The park is open to the public from sunrise to sunset.

The mission of the New Bern Historical Society is to celebrate and promote New Bern and its heritage through events and education. 

Tryon Civitan Food Drive To Benefit RCS



Nature's Run, Building A Community One House At A Time

Where we are from: We relocated to Merritt in Pamlico County in 2011, from Readington Township,

Hunterdon County New Jersey, where we raised our 2 boys, and owned and operated two successful Businesses. Once both boys where off on their own we put our plan into action and sold both businesses, our home of 20 years and headed south. We both like to say "We weren't born in the South, but we got here as soon as we could".

What we enjoy: We love boating, fishing and cruising. We enjoy taking care of our home, land-scaping and gardening. We especially love when we can get the family together here in North Carolina. When we are not here we are off cruising to explore some of the coastal towns of North Carolina and have traveled as far South as Key West. Hopefully one day we will cruise to the Bahamas.

We are both pretty much hands on people. Karen has found a love of the design/build process and enjoys it immensely. She designed our current home, and Russ oversaw the construction process and GC'd portions of Project.

How Karrus Ventures came to be: After a year or so of settling into our New Home and recovering from the impact of Irene on our lives, an opportunity presented itself. It was a real-estate short sale situation, the property was known as Nature's Run Sub-division, located on Kershaw Road. So in 2014, Karrus Ventures, LLC was formed. We really don't know what we were thinking, but here

What we do: With only one home in the community and the property severely overgrown, my husband, bless his heart, found himself on our little garden tractor working his tail off to start getting this property into shape. Needless to say it has improved immensely since then, and he now has

a bigger tractor. Together we maintain the property pretty much on our own. We do hire outside vendors when a job is just too much for us to take on.

There are a total of 23 lots in the community, three are privately owned, one has a newly built spec house owned by Karrus Ventures, LLC, and nineteen Lots are available for Sale. Of the nineteen lots, ten are deep water creek front, and nine are interior lots with deeded boat slips. This is a cul-de-sac community with no thru traffic, great for families.

There is also a 300' Community Dock with 10 Deeded slips at one end and a community area at the other end. We will sell lots or we can build to suit. All lots have approved septic permits and the waterfront lots have approvals for docks.

What we have done: Progress has been made, since the purchase we have built a home for Karen's parent's Farrell & Helen McCleary who also relocated here from NJ. A lot was donated to Military Missions in Action, and veteran group who in turn built a home for a wounded veteran. We completed our first spec home in fall of 2016 and it is being actively marketed through a local agent.

In the fall of 2017 we completed a 1900 Sq. Ft. Nature's Run Utility/Community Building. This Building is located in the Boat/RV Parking Area. The building is utilized to store equipment for maintaining the property, provides an indoor area to work on boats, and an area for a future Community Room

Newer Investors: Don't Panic If Bear Market Returns

If you're in your twenties or thirties, you might be starting to focus more on investing to reach your financial goals. Because of this, you also may be more attuned to moves in the financial markets. Depending on your age, you may have only experienced the bull market of the past nine years, so you might not know what to expect – or how to respond – whenever the next bear market strikes.

Of course, just recently, you've witnessed a market correction – a drop of at least 10 percent in the major stock market indices, such as the S&P 500. This sudden plunge made big news

and reminded many investors of how volatile the financial markets can be. But a full-fledged bear market usually isn't identified until the markets are down 20 percent from their recent highs. Plus, bear markets, unlike corrections, tend to linger for a while.

The last "bear" emerged from hibernation in October 2007 and stayed on the prowl until early March 2009. During that time, the S&P 500 declined by about 50 percent. Clearly, investors were not happy – but the market recovered and moved to new heights. This long and strong run-up may have obliterated your bear market memories, if you ever had them at all. And that's why you might want to familiarize yourself with some of the bare facts about bear markets:

• Bear markets may provide good buying opportunities. When gas is expensive, you may just buy a few gallons at a time – but when the price falls, you're probably more likely to fill up your tank. The

same principle can apply to investing – when stock prices are down, your investment dollars will buy more shares. And the more shares you own, the greater your ability to build wealth once the share price rises. In short, a bear market may provide you with a chance to buy quality investments at good prices.

• Bear markets don't last forever. No one can predict precisely how long bear markets will run, but they've typically been much shorter than bull markets. So, while you might not particularly like looking at your investment statement during a decline, you can take some comfort in knowing such downturns are a normal feature of the investment landscape.

• Bear markets don't affect all investments equally. If you only own U.S. stocks, your portfolio may well take a sizable hit during a bear market. But other types of investment vehicles may not be as directly affected – and some may even show positive results. Consequently, you could reduce the bear's "bite" if you also own a variety of other investments, such as international stocks, bonds, government securities, certificates of deposit (CDs) and so on. However, while owning this type of diversified portfolio can help reduce the impact of market volatility, it does not guarantee profits or protect against losses.

A bear market can be challenging. But by making the right moves, such as staying patient, looking for buying opportunities and maintaining a diversified portfolio, you may be able to prevent a market decline from becoming unbearable.



Green Party Candidates Will Appear On North Carolina Ballots state Green Party. "We're trying to get clarification right now on just

RALEIGH — The long, hard slog for the North Carolina Green Party is over. The state officially recognized the Green Party, allowing its candidates to appear on state ballots.

"It's something we've been working for, it seems like, forever," said J.J. Rizzo, co-chairman of the Triangle Chapter of the Green

The nine-member Bipartisan State Board of Elections & Ethics Enforcement voted unanimously March 27 to approve the Green Party petition to be recognized. Minor parties historically have had trouble gaining access to election ballots due to restrictive laws that favored Republicans and Democrats.

The Libertarian Party has had ballot status in the state off and on since 1976. A law passed in 2007 reduced the threshold for gaining ballot access from receiving 10 percent of the vote for governor to 2 percent. Mike Munger got 3 percent of the vote in the 2008 gubernatorial election, giving Libertarians continuous ballot status.

Ballot access for minor parties eased further last year with passage of Senate Bill 656 - a law enacted over Gov. Roy Cooper's veto. The Electoral Freedom Act lowered many barriers.

A party now can get on North Carolina's ballot if its presidential candidate qualifies for a general election ballot in at least 35 states. In 2016, Green Party presidential candidate Jill Stein was on the ballot in 38 states.

A party also can reach the ballot by collecting petition signatures equal to 0.25 percent of the total votes cast in the preceding gubernatorial election. The threshold had been 2 percent. The petitions must include 200 signatures from at least three congressional districts rather than four, the previous standard.





Middle and high school students immerse themselves in a year-long learning process that combines in-class curriculum with hands-on field experiences facilitated by resource professionals such as soil scientists, foresters and wildlife specialists. This intense training culminates in a competition where teams are tested in five subject areas: Soils/ Land Use, Aquatic Ecology, Forestry, Wildlife, and a current environmental issue. Scores determine winning placements.




