Pamlico County Covid-19 Vaccine Tracker: 21% People Fully Vaccinated Chastity Laskey USA TODAY NETWORK

Pamlico County has administered more than 6,929 doses of the COVID-19 vaccine, as of March 23, according to data from the North Carolina Department of Health and Human Services.

That's up 11% from the previous week's tally of 6,233 COVID-19 doses administered.

In Pamlico County, 21% of people living in Pamlico County are fully vaccinated as of March 23. The Centers for Disease Control and Prevention considers someone fully vaccinated two weeks after they've been given a single-dose shot (Johnson & Johnson) or a second shot (either Pfizer or Moderna).

North Carolina reported 899,164 total cases of coronavirus, an increase of 1% from the week before.

Pamlico County has one of the five highest percentages of their population fully vaccinated in North Carolina as of March 23.

The others in the top five are Chatham County, Orange County, Brunswick County and Dare County.

PCDRC Seeks Sustainability

The Pamlico County Disaster Relief Coalition (PCDRC) has been a beacon of light for the citizens of Pamlico County in the aftermath of destructive storms since Hurricane Irene in 2001. Through the effort of volunteers, that light has shined the brightest in the weeks and months after disaster has struck. The goal of the current Vice Chairman of the PCDRC, Bob Fuller is to make the PCDRC sustainable so that the light never goes out. "Think of it much like your fire department," states Mr. Fuller. "After the fire is out, you don't dismantle the fire department. Although the firefighters go their separate ways, it's always there ready to respond when the next fire occurs. That's the goal of the PCDRC." Mr. Fuller adds, "There is no end to the goodwill here in Pamlico County. We just have to have the organization in place that can tap into that goodwill when needed." The PCDRC is currently putting together a draft playbook that will help in the future to coordinate the many organizations already active

in our county as well as groups that may come to our county to help after a disaster. Matching people who want to help with the groups doing the help, then matching those groups with those in need. The PCDRC looks at this in both shortand long-term needs. Immediately after a disaster, the question that arises is, "Do you need food or shelter?" Utilization of local fire districts and volunteer fire departments are key to getting help out to the citizens affected within each community. After that, the long-term job of recovery and rebuilding begins. The two questions to ask in all of this is, "Do you need help?" and "Do you want to help?" Efficiently activating and utilizing Pamlico County's "volunteer brigade" as Fuller calls it, is the key. Keeping the PCDRC sustainable and active helps the current population, as well as future generations of volunteers in case of any disaster, not just Hurricanes. When he arrived on the campus of Morgan State College on a football scholarship in the fall of 1941, a fellow student took one look at Clarence Gaines and said, "You're as big as a house." The nickname stuck with the 6'3", 265-pound lineman for the rest of his life. Gaines was born in Paducah, Kentucky on May 21, 1923 where he attended high school and excelled not only athletically but academically as well, graduating as class salutatorian in 1941. While he attended historically black Morgan State College in Maryland on a football scholarship, he also played basketball as he once said, "to have something to do."

After he graduated from Morgan State in 1945 with a Bachelor of Science degree in Chemistry, his intention was to attend dental school, but his college coach suggested that he go south, to what was then known as Winston-Salem Teachers College to help out the coach there, another Morgan State

Alumnus, Brutus Wilson. When Coach Wilson left the following year for another job, the shortterm help-out became a long-term career and a coaching legend was born. Gaines became the head football coach, head basketball coach, trainer, athletic director and ticket manager. At a small school with limited funds, you did it all. After 3 years of this, he decided to concentrate solely on coaching basketball. He remained at what was now known as Winston-Salem State University for 47 years and racked up 828 wins over those years, which when he retired in 1993, placed him at number 2 on the all-time list of winningest NCAA coaches. His teams won the Central Intercollegiate Athletic Association (CIAA) Championship 8 times, and they won the NCAA Division II National Championship in 1967. In 1982 he was inducted into the Basketball Hall of Fame and was a member of the first class of the College Basketball Hall

Records come and go. But if you touch people's lives, they remember you," Gaines said. Gaines wasn't a great small college coach or a great small black college coach. He was a great basketball coach period. Not too shabby for someone who took up basketball "to have something to do." Clarence "Big House" Gaines passed away on April 18, 2005, in Winston-Salem, North Carolina at the age of 81.





Pamlico Community College Register now for the Pamlico Community College Foundation's May 8 fundraising golf tourney

The Pamlico Community College Foundation is inviting you to swing the clubs for a great cause on Saturday, May 8, as it hosts its 21st Annual CarolinaEast Cup Fundraising Golf Tournament at Minnesott Beach Yacht, Golf & Country Club.

Proceeds from the tournament will be used to support student scholarships at Pamlico Community College.

"As our community and country slowly emerge from the COVID-19 pandemic, a spirit of optimism is beginning to take hold," said PCC President Dr. Jim Ross. "One of the first signs that things are on the way back to normal is the scheduling of the PCC Foundation's annual May golf tournament. Organizers showed us last fall they can host a golf tournament safely and thereby help our students reach their academic goals. We're excited to see the tournament return to its usual place on the calendar."

Even though last May's golf tournament had to be postponed because of the pandemic, Foundation leaders were not deterred. Working with local health officials, the PCC Foundation organized an all-outdoor tournament last October that included mask-wearing in large groups and social-distancing requirements, plus staggered tee times between 8:30 and 9:30 a.m.

The May 8 tournament will follow the same format, including boxed lunches - no indoor meal - for participants.

"We were pleased with the tremendous amount of enthusiasm we got for last October's tournament and we are hoping for a similar response this May," said PCC Foundation Executive Director Michelle Noevere. "We are extremely thankful for the support we have received from our community, including CarolinaEast Health System, our other sponsors, our players and the great staff at Minnesott Yacht, Golf & Country Club."

The registration fee is \$70 per person (10 percent off, or \$63 per person, if you register by Friday, April 16) and includes breakfast biscuits, a goody bag with snacks, a boxed lunch, golf and cart, and mulligan and tee. Individuals who are not part of a four-person team when they register will be grouped together for play.

Prizes will be awarded for the first-, second- and third-place teams, and there will be a putting contest.

To build momentum for this year's tourney, the Foundation is offering a 10 percent discount to those who register by Friday, April 16.

As always, the tourney's goal is to provide support for PCC students who want to improve their lives and their community.

"You know Pamlico Community College students," Noevere said. "They're in your community and ours. They come from all walks of life. They're parents, they work and support families, they're training for a new career or they are updating skills for their current job."

She continued, "Maybe they're planning on going on to a four-year college or university. They are your future health care professionals, first responders, business leaders, welders, environmental scientists and more. They're working hard to make their dreams come true, and we want to work hard to help them succeed."

Ross agreed, adding the Foundation





your IRA for decades to help pay for your retirement. But if you don't need all the money, you may want to leave what's left to your children or

if you want to ensure they get the most from this inheritance, you'll need to do some planning.

Here's a little background: Up until a couple of years ago, when you left the proceeds of your IRA to your beneficiaries, they could choose to "stretch" required withdrawals over a long period, based on their life expectancies. These required withdrawals were generally taxable, so this "stretch IRA" allowed your beneficiaries to greatly reduce the annual taxes due, while benefiting from longer tax-deferred growth potential. And the younger the beneficiary, the longer the life expectancy and the lower the withdrawals, so this technique would have been especially valuable for your grandchildren or even great-grandchildren.

Changes in laws affecting retirement accounts have significantly limited the stretch IRA strategy. Now, most nonspouse beneficiaries must withdraw all assets from the IRA within 10 years of the IRA owner's death. The beneficiary generally does not have to take out any

You might contribute to money during that 10-year period, but at als - technically called required minithe end of it, the entire balance must be withdrawn - and that could result in a pretty big tax bill.

> The stretch IRA strategy can still be used for surviving spouses, beneficiaries who are no more than 10 years younger than the deceased IRA owner, and beneficiaries who are chronically ill or disabled. Minor children of the original account owner are also eligible for a stretch IRA but only until they reach the age of majority, at which time the 10-year rule applies.

> So, if you want to leave your IRA to family members who don't meet any of the above exceptions, what can you do?

> One possibility is a Roth IRA conversion. You could convert a traditional IRA to a Roth IRA over your lifetime, so your heirs would receive the Roth IRA. They would still be required to withdraw the assets within 10 years, but unlike with a traditional IRA, Roth IRA withdrawals are generally tax-free. These conversions are taxable, so you'll want to consult your tax professional in addition to your financial advisor, to determine if this strategy can help you achieve your legacy goals.

> Another option is to purchase life insurance, which can provide a specific dollar amount to your heirs or be used to help cover additional taxes. This may be especially advantageous if you are 72 or older, in good health, and taking withdraw

mum distributions - from your retirement accounts, such as your traditional IRA and your 401(k). If you don't really need the money, you can use these withdrawals to pay for some or all of the insurance premiums. Life insurance can't replace an IRA as a means to save for retirement, though, so you should consult with your financial advisor to make sure you are working toward all your goals.

In any case, if you have a sizable IRA or you don't need the funds that you're required to take from your retirement accounts, you may want to start thinking about what you want to do with the money. The more thorough your legacy planning, the better your chances of meeting your legacy goals.

Reminder: Secure Your Load for Litter Free Roads



6th Annual 5K Walk/Run for Sickle Cell

The Neuse-Pamlico Sound Women's Coalition is a non-profit organization of influential, professional African American women who are making a difference in their communities. They are mentors, advocates and volunteers committed to community involvement and enhancement in areas of health and wellness, youth, and family services. The NPSWC held its 6th Annual 5K Walk/Run for Sickle Cell virtually this year during the week of March 13-20, 2021. NPSWC members met on Saturday at Union Point Park in New Bern to raise awareness of the event that is their only fundraiser to support fam- Neuse-Pamlico Sound Women's Coalition fundraiser



ilies who are living with this devastating disease. "Together we will assist with treatment, transportation and the expenses of other daily challenges," said Mit McClean, NPSWC President.

NPSWC held a special zoom awards ceremony on Sunday, March 21, announcing all the race winners. The program also featured some corporate sponsors who shared why they support this SCD event and how the local women's group is making a positive difference here in Eastern North Carolina. Guests included Brandy Popp from Carolina East Health Services, Dr. Beng Fuh, Director of ECU Sickle Cell Comprehensive Clinic, Kathy Norcutt, Executive Director of Piedmont Community Health Services and Sickle Cell Agency, Reverend Curtis Donald of Mount Zion Baptist Church in Beaufort, Dorothy Dove of Oscar's Mortuary, and Alice Garrison from United Community Fellowship Church in New Bern.

Sickle Cell Disease is an inherited blood disorder that affects more than 100,000 people in the United States and 5,000 patients in North Carolina, 90 percent of those with SCD having African ancestry. Approximately 80 infants are being diagnosed in newborn screenings each year. According to the nonprofit, the disease occurs in about 1 of every 365 African American births and about 1 out of every 16,300 Hispanic American births. This debilitating disease can cause anemia, severe fatigue, decreased oxygen, episodes of painful swelling in the hands and feet, and frequent infections as well as delayed growth and vision problems. There is no cure for Sickle Cell, but strides have been made in managing these symptoms.

The efforts of the NPSWC have been extremely successful. The virtual race this year netted over \$13,000 which will go directly to individuals or families for things such as transportation,

medical expenses, utilities, and even internet access for education. NPSWC partners with Piedmont Community Health Services and Sickle Cell Agency, as well as East Carolina University Comprehensive Sickle Cell Center, to identify needs in our community. In 2017, the NPSWC decided to use some of the proceeds to award \$1,000 scholarships to individuals with SCD. They have awarded a total of five scholarships in the past four years totaling over \$9,000. Individuals with SCD, who are high school seniors, are eligible for a scholarship and they are currently accepting applications. They also award "renewal" scholarships to community college students or individuals currently enrolled in post-secondary schools who have SCD. Jamal A. Jones Memorial Sickle Cell Scholarship



Jamal A. Jones, son of Greg and Vickie Moseley-Jones, was born with Sickle Cell Disease (SCD), a devastating blood disorder that has no cure. He grew up in the Broad Creek community near Oriental and was a 2001 graduate of Pamlico High School. He attended Craven Community College, graduated from Lenoir Community College with a degree in culinary arts, and graduated from North Carolina A&T State University with a degree in information technology. He loved learning and continued to pursue his education despite the many challenges of living with the disease. Jamal lost his battle with SCD on January 20, 2021, while at Duke University Medical Center. He is now being honored for the distinguished way he lived his life and his

courageous fight to the very end.

Six years ago, the Neuse-Pamlico Sound Women's Coalition premiered their first 5K Walk/Run for Sickle Cell to raise funds necessary to assist individuals and families battling the disease. This race was birthed by then President Judy Pierce, along with the efforts of Vickie Moseley-Jones who understood firsthand the challenges that people faced with SCD. Vickie inspired NPSWC members to take an active role in their communities to educate the public. With a portion of the proceeds from this race, NPSWC was able to award a \$1,000 scholarship to graduating seniors with SCD, to assist with their educational endeavors. The scholarship is renewable throughout the students' years in a college of their choice. To date they have helped families in Pamlico, Jones, Carteret, and Craven Counties. This year, NPSWC renamed this scholarship, the Jamal A. Jones Memorial Sickle Cell Scholarship, to

honor Jamal's legacy and assure that his memory will live on as an inspiration to others. The community honored Jamal on Saturday, March 20, by turning out for a 5K Memory Walk in Bayboro sponsored by the Women of Purpose Missions at Mt. Olive Missionary Baptist Church in Mesic where his father is a member. The Government Transparency Act Of 2021/A Bill To Open State And Local Government Personnel Records By Paul Mauney and Bill Moss



Transparency Act of 2021. Primary sponsors of this monumental bill, Sens. Norman

Sanderson (R - Carteret, Craven, Pamlico); Bill Rabon (R - Bladen, Brunswick, New Hanover, Pender); and Joyce Krawiec (R - Davie, Forsyth), have filed one of the most important transparency bills in recent history. By providing meaningful public access to personnel records of state and local government employees, the bill would allow North Carolinians to hold elected leaders accountable for the first time when it comes to hiring, firing and other personnel action.

Unfortunately, for as long as anyone can remember, North Carolinians have been forced to suffer under the weight of one of the worst public records laws in the country. For more than 50 years, transparency of North Carolina government has been badly hindered by the lack of public access to arguably the most important government records, those surrounding the hiring, promotion, suspension, demotion, termination or discipline of state and local government employees. And yet public access to these records - vital to holding public officials from teachers to law enforcement officers accountable— is guaranteed by the law in the states surrounding North Carolina and some 35 others.

Thanks to Senate Bill 355 we now have the chance to crack the door ever so slightly to allow the public to learn the reasons for terminating, promoting, suspending, demoting or disciplining a government employee. From our perspective, it is a sea change long overdue, and the North Carolina Press Association strongly supports the bill.

This true transparency bill stands in stark contrast to so-called criminal justice "reform" bills already filed this legislative session. That piece of legislation would create a pair of databases containing law enforcement disciplinary and use-offorce incident records that law enforcement agencies would see, but not the public. The bill does nothing to breach the wall that prevents the public from knowing, for instance, that officers with a record of misconduct have been passed from agency to agency or from finding out why a division captain was demoted to patrol officer.

At the end of the day, what is our government trying to hide in refusing to make public the reasons for disciplining, suspending, demoting, or even firing government officials?

Instead of inspiring public confidence in government, blocking public access to government personnel records of this kind simply creates suspicion. And that erodes our public institutions, which are staffed by and large with principled and dedicated people.

We are thankful that these three veteran Republican members of the North Carolina Senate understand that the culture of secrecy that barricades government employee personnel records in our state is public policy that fails the public. The current policy prevents all North Carolinians from being equipped with information necessary to separate good teachers and law enforcement officers from bad ones. But the winds may be shifting and we say, it's high time.

Civil War Hospital Re-discovered in Downtown New Bern by Claudia Houston, NBHS Historian

NEW BERN, NC, The New Bern Historical Society (NBHS) is excited to announce the discovery of an existing building in downtown that served as both a Confederate and Union hospital during the Civil War. Historian and author Wade Sokolosky recently discovered several wartime documents that identified a military hospital on Craven Street, "next to the Progress Building." After many discussions, much research, and a little bit of luck, it was determined that the Brick Block Building located on the 200 block of Craven Street, was first used by the Confederates beginning in January 1861. We are pleased to share the story of the research and the discovery.

The January 31, 1862 edition of the New Bern Daily Progress reported "the rooms adjoining the Progress building have been taken for a hospital and are being overhauled and refitted for that purpose under the supervision of W.A. Holt, Confederate Surgeon. The Dr. is a man of ... judgment as will be seen, not only by the internal arrangement of the building but by the improvement in the way of cleaning up, whitewash-

ing etc...." The Branch General Hospital, as it was formally identified by Confederate authorities, operated through the Battle of New Bern fought on March 14, 1862. On the day of the battle, Surgeon Holt labored to remove his patients to the Atlantic and N. C. Railroad depot in town, where they were evacuated toward Kinston.





Upon occupying New Bern, Union authorities impressed several local buildings for use as hospitals. In a report published in the Boston Medical and Surgical Journal, Volume 66, 1862, Surgeon Samuel E. tal by the Confederates. I found about 150 bedsteads, with beds and coverings in a most filthy condition; one man dead, and another dying, left by the rebels in their hurried flight. I pressed about a dozen contrabands, and had the building scrubbed from top to bottom, and all the beds and clothing aired and sunned." This past January, the Brick

Block Building's owner graciously allowed several of us to tour the building. While sharing with us a general history, the owner acknowledged that he was puzzled by the presence of "whitewashing" in only a portion of the building-research had revealed only a section of the building had served as a hospital. Civil War hospitals were routinely whitewashed (painted white) to enable better lighting at night, as well as for observing cleanliness. Remarkably, because the hospital part of the building had been closed off for decades and subsequently spared from later modifications, it was like a time capsule. To see the whitewashing was like stepping back in time. This indeed was the hospital. There we were, standing in a building that had previously served 156 years ago as a hospital. Based on his research, Sokolosky revealed to the owner that the Brick Block Building was one of three known North Carolina hospital buildings from the Civil War still standing, not counting historic homes or churches that were used temporarily as hospitals.

This is an exciting discovery and further adds to our knowledge of the existence of Civil War hospitals in Eastern Carolina and enriches the significant history of New Bern. Sokolosky, a well-known historian and author is in the process of completing a two-volume series that discusses the history of Civil War hospitals in the Old North State. The first volume, titled, North Carolina Civil War Hospitals: Confederate, is due out in 2022.

Those who worked together to solve this mystery and discover the hospital were Wade Sokolosky; Nathaniel Glasgow, a recent graduate of Appalachian College; Claudia Houston, Historian of NBHS; and Jim Hodges, NBHS Curator, along with the owner of the Brick Block Building. It should be noted that the former hospital is on private property and not available for public viewing.

We are currently pursuing the locations of two other Confederate Hospitals here in New Bern prior to the Union occupation.






Tideland EMC continues upgrading the power lines along Trent and Straight Roads. Lee Construction will continue this work on Orchard Creek Road in April.

The Wall That Heals Coming to New Bern

The three-quarter scale mobile replica of the Vietnam Veterans Memorial is coming to New Bern. The 375-foot-long memorial and the education center that travels with it will be set up at Lawson Creek Park beginning on April 8 and lasting until April 11. Just like the permanent Vietnam Veterans Memorial located in Washington, D. C., the traveling replica contains the names of the more than 58,000 Americans who were killed in the Vietnam War. For the final leg of the mobile wall's journey into New Bern, there is a planned escort ride that will leave Morehead City at approximately 4 PM on April 6 from the vacant Kmart parking lot on Arendall Street and arrive at Lawson Creek Park at 5 PM. It is open for motorcycles as well as classic cars and hot rods. Anyone planning to participate in the escort ride should plan to be at the staging location between 2 and 3:30 PM.




SBA Launches Portal to Begin Accepting Shuttered Venue Operators Grant Applications on April 8

WASHINGTON - The U.S. Small Business Administration<http://www.sba.gov> is launching a splash page for the Shuttered Venue Operators Grant (SVOG) application portal<https://www.svograntportal.sba.gov/> today in anticipation of opening applications for the much-anticipated critical economic relief program on Thursday, April 8, 2021.

"Help is here for venue operators hit hard by the COVID-19 pandemic. The SBA has worked diligently to build the Shuttered Venue Operators Grant program from the ground up to assist and address the diverse eligibility requirements of each type of applicant and we will open for applications on April 8," SBA Administrator Isabella Casillas Guzman said. "The SBA knows these venues are critical to America's economy and understands how hard they've been impacted, as they were among the first to shutter. This vital economic aid will provide a much-needed lifeline for live venues, museums, movie theatres and many more." Prior to the official SVOG application opening, the SBA will host a national informational webinar to highlight the application process for potential eligible entities from 2:30 to 4 p.m. ET on Tuesday, March 30, 2021. Those interested in participating can register here<https://svogapplicationinfo.eventbrite.com>. The SVOG program was established by the Economic Aid to Hard Hit Small Businesses, Nonprofits and Venues Act, which appropriated \$15 billion for it. The American Rescue Plan Act<https://www.congress.gov/117/bills/hr1319/ BILLS-117hr1319enr.pdf>, signed into law by President Joe Biden on March 11, 2021, appropriated an additional \$1.25 billion, bringing the program funding to a total of \$16.25 billion, with more than \$16 billion allocated for grants.

To ensure eligible venues do not miss a window to receive assistance through the Paycheck Protection Program<http://www.sba.gov/ppp>, the American Rescue Plan Act also amended the SVOG program so entities that apply for a PPP loan after Dec. 27, 2020, can also apply for an SVOG, with the eligible entity's SVOG to be reduced by the PPP loan amount. The PPP loan applications have been updated to reflect this.



As the SBA builds and prepares to open the program, the dedicated SBA website, www.sba.gov/ svogrant<http://www.sba.gov/svogrant>, which includes frequently asked questions<https:// www.sba.gov/document/support-shuttered-venue-operators-grants-faq>, video tutorials<https:// www.sba.gov/funding-programs/loans/coronavirus-relief-options/shuttered-venue-operators-grant#section-header-12> and other SVOG details, is the best source for information for those looking to apply for a grant. To prepare in advance of the SVOG application portal opening on April 8, potential applicants should get registered in the federal government's System for Award Management (SAM.gov), as this is required for an entity to receive an SVOG, and reference the preliminary application checklist<https://www. sba.gov/document/support-shuttered-venue-operators-grant-preliminary-application-checklist> and eligibility requirements<https://www.sba. gov/document/support-shuttered-venue-operators-grant-eligibility-requirements>.
